This charge will be made if You tell Us You wish to cancel Your prepaid booking but You give Us less than 48 hours notice.

This charge will apply if You did not cancel Your pre-paid booking but You do not collect Your Vehicle.

Applies if We have to charge You for damage caused to the Vehicle whilst You are in possession of it. This charge pays for the back-office resource required to process associated paperwork.

This applies if the Vehicle is damaged but not repaired immediately. It pays for the cost of a review to compare all data relating to the damage. This is in addition to the Damage Administration Fee.

This applies if the Vehicle is damaged and needs to be repaired immediately. It pays to liaise with the repairers to instruct how it will be repaired and the cost. This is in addition to the Damage Administration Fee.

Applies if We have to provide Your details to any third parties (for example for unpaid congestion or parking charges) or if We have to replace Accessories or keys.

Applies if We have to recover unpaid charges associated with Your rental. Reasonable legal fees, statutory court costs and interest will be payable in addition to this fee.

Applies when You notify Us that You wish to extend the length of Your Hire Period.

Applies when You fail to return the Vehicle on time or within the grace period.

Applies if You do not let Us know that You wish to extend the length of Your Hire Period at least 2 working hours before it is due to be returned to Us. This is charged in addition to the daily Rental Charges.
